1. Personal Protective Equipment

1.1 What is definition of Person Protective Equipment

- Equipment worn to minimize the exposure to hazard that can cause serious workplace injuries and illness.
- The PPE may includes Coverall, hard hat, safety shoe, safety glove, ear plugs and also the safety glasses.

1.2 List out all compulsory PPE required to be worn while perform job offshore

- Coverall, safety shoe, ear plugs, hard hat, ^{impact gloves} ~~ear~~ plugs and safety glasses.

1.3 List the area where the PPE should be worn while working


- Working on or around hot, wet and slippery surfaces.
- working around overhead tools or machinery
- working when electrical hazards are present.

1.4 List the PPE should be worn while doing maintenance at tools and equipment

- Coverall, safety shoe, ear plugs, hard hat, impact gloves and safety glasses.

1.5 PPE should you wear while working in mercury and H₂S are

- Coverall, respiratory protection, H₂S detectors, safety gloves, safety shoe, hard hat and safety glasses.

4 Hazard ID and Incident Reporting

4.1 How can we report hazard or unsafe act?

- Lodge a report to supervisor or location HSE officers.

4.2 If there is an incident happened at workplace what should we do?

- All employees are required to immediately report at the supervisor or location HSE officers if an incident happened.

4.3 What is the incident reporting process?

- Write on Hazard Hunt Card : ① observe the unsafe act or unsafe condition
② Intervene/action ③ Finding writing ④ Agreed solution ⑤ Follow up (if any)
⑥ Closure.

4.4 What is the purpose of Hazard Hunt? And how does that help to be safe?

- To inspect all our facilities and locations for any unsafe act/condition hazards and to take action where control measures need to be improved.
- By detecting early any unsafe act/condition hazards, any incident can be avoided from happening.

4.5 Please explain what is Near Miss

- unplanned event that has potential to cause, but does not actually result in human injury, environmental or equipment damage, or an interruption to normal operation.

4.6 In case of emergency,

a) Firstly what should you do?

Report immediately to the supervisor or location HSE officer.

b) Where is DB assembly point (Base)?

outside DB gate front gate.

5.1 How to prevent an accident before executing certain job or activities

- Make a job Hazard Analysis to identify hazards before they occur.
- This can prevent future incident to occur.

5.2 What is the purpose of Safety Morning Meeting

- To brief the important of safety in our daily life.

5.3 What is the purpose of briefing and Debriefing

- A valuable opportunity to ensure that all members have a clear understanding of the plan for the operation and an opportunities for team members to gain clarity of direction.

5.4 What is Permit To Work (PTW)


- A written record which authorized specific work at specific location for specific period of time.

5.5 Explain what do you understand from Job Safety Analysis and how does this help you to be safe?

- Any hazard or incidents can be controlled or minimized and possible to avoid serious illness or injury due to precaution already taken and informed early.

5.6 What are the safety precautions to be taken during tool maintenance at warehouse?

- Wear a proper PPE and apply stop work Policy if needed.

- An authorized written record to work at specific location for a specific period of time.

5.9 When do we apply the work permit

- Apply when we want to work at specific location for a specific of time.

5.10 What are the safety precautions to be taken during test lubricator and BOP?

- make sure to barricade the workplace and do the test at the test bay.
- Do the job safety Analysis.

5.11 What are the safety precautions to be taken during test Control Panel?

- make sure to barricade the workplace, then check for the hoses connection for any leaking and be guided by competent person.
- Do the job safety Analysis.

5.12 Why JSA, Risk Assessment and Job Plan need to be discussed among the team member? How does that work?

- To ensure the team member aware the procedure and risk during work.
- This can avoid any future risk / hazards during the procedures operation.

5.13 While working, you found that there is something unsafe. What should you do?

- Applied the Stop Work Policy immediately and report to the supervisor or location HSE officers.
